 - Building Safer Communities Fund Part of Public Safety of Canada, focuses its efforts on gun, gang and safety in youth. They are currently developing and working through a work plan with hopes to be operational by April 2024.
 - Team is made up of:
 - 2 Case Managers Can support families to support youth 12-17. They support with any type of gang
 - 2 Educators Goal is to mobilize and work alongside other services in education
 - Referrals to the team will be made through Lethbridge Police Services
 - Once operational they will be looking for groups to partner with to mobilize supports and facilitate education on the justice system.

 - ii. Stabilization Updates
 - Have removed the Self-Referral pathway due to feedback and issues with the process resulting in people not being supported while funded or denial of applications due to incomplete applications. Individuals not attached to T2 SN now will book an appointment with Community LINKS to ensure applications are complete and supports and plans are in place prior to approval.

 Up to date referral tools are on the LHA website, although there is currently a waitlist for housing programs. Working through transitions as programs shift with the end of the year.

 - ii. Indigenous
 - No updates at this time







iii. Youth

- There is now an extra case manager for youth. The Opportunity Hub is open and busy.
- Youth are finding increased issues with finding jobs, leading to issues in food security, and being unable to break even with what jobs they do find.

iv. Shelter

- Currently moving through a season of illness. Clients are going to the ICU because they are afraid of/unable to access regular healthcare supports. Nurses are at the shelter Tuesdays and Thursday but are over capacity.
- Tax Clinics at the shelter
- Individuals that they are seeing are very complex, and there are a number of unique challenges with the high acuity individuals. Many need medically more than the shelter can support and there is a lack of supportive living options.

v. General

- Family Centre 3 Counsellors who work out of their with a private practice are losing their subsidy, leading to some limitations in individuals ability to see them.
