CSD Update- Kristina wanted everyone to know PSN Seniors Training is on May 18. Looking to go to City Council to ask for a one-time Community Access Engagement Service Fair that would occur in the fall. The goal of this fair is to align with the Reaching Home mandate by educating service providers about the coordinated access system, fostering collaboration among service providers and the decentralized intake process, promoting fair and equitable access to housing and support services, optimizing available resources, preventing homelessness, and raising awareness among service providers about the coordinated access system and how they can participate to improve outcomes for individuals and families experiencing homelessness.

CMHA Updates- David has stepped in to facilitate the meetings as Kala is no longer with CMHA.
