- **Stabilization Fund Updates**

 - Now accepting applications again.

 - SL3 and SL4 being discharged and not having any supports in place.
 - Sometimes Homecare with come to the Shelter. Seems to depend on the comfortability of the staff. Seems to be a gap/disconnect in providing this service.
 - As post-secondary students return, College is reporting a high amount of people that are living out of their cars. Seems to be a community trend in general with the Lethbridge population.
